The Alumni Association of ALC/Chapters (registered and functional) contributes significantly to the development of the institution through financial and other support services.

The Institute has a registered Andhra Loyola College Alumni Association (ALCAA) for building strong bond between alumni and present students. The alumni give support to the students through interaction, financial funding, guidance and placement. The Alumni Association of the Institute is called as ALCAAA i.e. ANDHRA LOYOLA COLLEGE ALUMNI and ALUMNAE ASSOCIATION. Andhra Loyola College Alumni Association" has been registered as a Society under the Societies Registration Act. 'The College invites all the alumni / alumnae to enrol themselves as Life-members and strengthen the Association to play an active role in fulfilling its objectives. The Management desires to caution all the alumni/ alumnae that only ALCAA is the permitted body of old students of this College and hence nobody should be influenced or carried away by any other individual or group of individuals about forming another association as Management did not permit anybody to do so.'

Objectives of the Alumni association:

- To encourage and promote close relations between the Institution and its alumni and among the alumni themselves.
- To promote and encourage friendly relations between all members of the alumni body, an interest in the affairs and well-being of the Institution.
- To provide and disseminate information regarding their Alma Matter, its graduates, Faculties and students, to the alumni.
- > To initiate and develop programs for the benefit of the alumni.
- To assist and supporting the efforts of the Institution in obtaining funds for development.
- To serve as a forum through which alumni may support and advance the pursuit of academic excellence at the Institution.
- To guide and assist alumni who have recently completed their courses to obtain employment and engage in productive pursuits useful to society.

- To organize and co-ordinate reunion activities of the Alumni and let the Alumni acknowledge their gratitude to their Alma Matter.
- To collect, publish and distribute such information as may be useful to the alumni and their Alma Mater.

Activities and Contributions:

- Alumni have donated funds to assist the Poor & Merit students of the Institution.
- Alumni are included as members in the Board of studies of all departments. They are invited for meetings at the college and they interact with their teachers and express their suggestions on curriculum revision.
- Few Alumni gave Guest lecturers to the existing students on some contemporary technological developments and career guiding focuses. Alumni meets are arranged in the academic years 2018-2019, 2019-2020, 2020-2021, 2021 and 2022- 2023 respectively.

The Alumni Association of ALC/Chapters (registered and functional) contributes significantly to the development of the institution through financial and non-financial means during the last five years.

The Alumni has taken up the following activities for the Academic Years 2018-2019 to 2022 – 2023.

- a) Construction of First Floor for ALCAA School.
- b) Contribution to Central Reserve Police Force .1.74 lakhs
- c) ALC ALUMNI has taken a call to spread our mission and vision with the motto of 'Solidarity & Service' (2018-2019).
- d) During Covid 19 crisis, "Nutrition Support to Police" was given to police by donating 67500 Eggs (2019-2020). For this, they spent more than Rs 3 laks.
- e) RO Drinking Water Plant was set up both in the North and South Blocks abutting the College Main Office and the O/o Controller of Examinations at a cost of Rs 15, 30, 000/- (2020-2021).
- f) The much awaited renovation of College Main Office was undertaken at a cost of Rs 15,00,000- with the financial support of Andhra Loyola College Alumni Association (2020-2021).

Chairperson and quorum:

Mr Harish Chandra Prasad, the President took the chair and Conducted the session. He also expressed his happiness about the prompt response of the members to attend the meeting with a short notice. The following points were discussed:

The Chairperson noted that the meeting was quorate and accordingly opened the meeting.

The following items were taken up for discussion and Resolutions Passed:

- Fr A Rex Angelo SJ, Director ALCAA congratulated Sri Harish Chandra Prasad President of ALCAA.
- He also acknowledged the contributions made by all the members of the Executive Committee and in a special way Dr Movva Srinivasa Reddy, Sri Siva Sankar, Sri T Ramesh, Dr Mohan Prasad, Sri Rama Chandra Rao, Dr K Pattabhi Ramaiah, and Viswanatham among others.
- Sri Harish Chandra Prasad, President expressed his gratitude to Andhra Loyola College Management for encouraging and permitting the old students to start ALCAA with an office in the campus.
- > The President delegated the following duties:
 - The Secretary along with Treasurer should open a bank account in any nationalised bank.

- The Secretary should register the logo of ALCAA.
- The Secretary should apply to the Income Tax Department for 12A facility initially and subsequently 80G for IT exemption.
- We should modify and finalise the rules and regulations of the Society and incorporating the same if Required.
- Fr Director reminded the officials and members of ALCAA about their obligation to follow the job description of different offices/roles as envisaged in the Memorandum of Association and to deliver their duties promptly.
- The EC members have unanimously agreed to recruit a permanent employee who can take care of all the transactions viz., maintaining records, minutes of the meetings, filing for IT returns, etc. Mrs N Bharathi from the Dept of MBA, ALC was requested to take care of such things until the appointment of permanent staff for ALCAA Office.
- Mr T Ramesh EC Member was delegated the task of recruiting the above-said employee.
- Fr Principal was very generous in assuring necessary arrangements (hospitality) to all the EC members whenever they would attend the meetings for the next three years.
- Dr Mohan Prasad and Sri Rama chandra Rao EC Members were suggested to meet Fr Rector / Principal to clarify any issue with regard to the Income and Expenditure of Fr Devaiah Auditorium fund and any amounts of Alumni Fund with College shall be transferred to the Newly opened Bank Account of ALCAA.
- Sri Ramesh EC Member was given the responsibility of appointing a structural engineer for the renovation of Fr Devaiah Auditorium with latest facilities.
- The President and Fr Principal were concerned about creating awareness of ALCAA among the present students of the College, who would be the future members of ALCAA.
- The EC requested Fr Principal to send a letter to the Registrars of Societies of Andhra Pradesh and Telangana to prevent mushrooming of different alumni associations using the name of Andhra Loyola College or ALC. It was declared that ALCAA would be the only authorised alumni association of Andhra Loyola College to spread our noble mission and vision with the motto of 'Solidarity & Service'.
- Fr Director shared his experiences of witnessing other alumni units in India organising curricular, co-circular and extra-curricular activities for their respective

alma mater like the Alumni Associations of Loyola College, Chennai and St Xavier's College, Kolkata. He envisaged similar dynamism by ALCAA too. He also strongly suggested that EC members and officials should leave no stone unturned to re-activate the different chapters of ALCAA all over the globe.

- Fr Director also strongly advocated to the College Management that the President, Secretary, and the EC members of ALCAA should be invited to all the major functions organised by the College and the President should be seated on the stage along with other dignitaries on the College Day and other important functions.
- The President suggested arranging a one-day brain storming session to all old students to remind them of their responsibility and belongingness to their mother institution. The Meeting was Chaired by Mr.Y.Harish Chandra Prasad, President of ALCAA

Resolutions:


- 1) It was resolved that the alumni association of ALC should be registered with aname, place, and door number as per law.
- It was unanimously accepted to choose the new name, ALCOSA Andhra Loyola College Old Students'Association for the old students' Association.
- 3) It was resolved that ALCOSA and ALCAACT (Andhra Loyola College Alumni Association Charitable Trust)would be two different entities.
- 4) It was resolved that there would be only one membership namely, Life Membership.
- 5) It was resolved that the Registration Fee of Life Membership would be Rs 2000/-per head.
- 6) It was resolved that the members of ALC staff who were not formerstudents of ALC would not be members of ALCOSA.
- It was resolved that those who were associated with ALC would be honorary members of the Association.
- It was resolved that the By-laws whichwere approved during this meeting would be sent to the old students through E -communication and their replies within the stipulated time only would be considered.
- 9) It was resolved that the Re-unions of old studentswould be organised by ALCOSA, for which Mr Apparayulu would be the Organising Secretary under the leadership of Chairman of the Association.
- 10) It was resolved to propose to the College authorities that the President of ALCOSA could be invited to be present on the stage along with the other invited guestsatimportant events organised by the College.
- 11) It was resolved that a special committee would be nominated to monitor the financial transactions of the Association. In this regard, Dr Mohan Prasad and Sri Ramachandra Rao were requested to negotiate with the College Management with special reference to the communication between Sri Harish Chandra Prasad and Fr GAPKishore SJ.
- 12) It was resolved that the Annual General Body Meeting of our old students be conducted during which all resolutions would be ratified.
