RNIT Solutions and Services Private Limited, a company incorporated under the Companies Act, 2013 having it's registered Office at F-310, Block- A, Hema Durga Towers, Miyapur, Hyderabad-500049, Telangana, represented by its Executive officer Mr. Sastri Malladi , duly authorized by it's board resolution dated 09 July 2019 (hereinafter referred to as "Service")

RECITALS:

- 1. WHEREAS, after due examination and verification of the antecedents of the Service Provider, Institution on being convinced that the Service Provider is competent and capable to provide it with all the services pertaining to the RLMS softwae application, accepted the proposal and agreed to engage the Service Provider for the Software Services, Installation, Implementation Services, Installation Services and Training Services(hereinafter referred to as "project" at Andhra Loyola College, Vijayawada in pursuance of this agreement.

NOW THEREFORE, in consideration of the mutual covenants, terms and conditions and understandings set forth hereinafter this agreement, both the Parties agree as under:

1. COMMENCEMENT AND DURATION:

Both the parties agree that this agreement shall be effective from the date of execution of this agreement and shall be valid successful completion of the project or till earlier termination as mentioned herein.

2. <u>SCOPE OF WORK:</u>

- a. The Institution acknowledges and agrees that the customized learning management solution known as RLMS software and the first year annual maintenance support services for the said software provided free of any additional cost is strictly limited to this





transaction alone. Both the parties agree that after completion of the first year of providing annual maintenance support services, if the parties decide to continue the annual maintenance support services beyond 2 years further i.e. 10% of the total work order value shall be payable per year by the Institution to the Service Provider towards annual maintenance support charges besides the parties entering into a separate agreement for the annual maintenance support services.

b. Both parties agree that in the event, the Institution at a later stage requires additional services not contemplated by this agreement, then the Institution shall submit in advance to the Service Provider a written request for the additional services at cost in addition to the Total Consideration mentioned herein. It is further agreed by the parties that if such request of the University is accepted by the Service Provider, then the same shall be provided at such consideration as may be mutually agreed by the parties.

3. TOTAL CONSIDERATION:

Both the parties agree that the for the services rendered by the Service Provider in pursuance of this agreement, the Institution shall pay the Service Provider an amount of Rs.32, 00,000/-(Rupees Thirty Two Lakhs Only)(details of which are as mentioned in the proposal submitted by the Service Provider and the work order dated ________ issued by the Institution in pursuance of the said proposal) as Total Consideration. It is further agreed by the Institution that the total consideration mentioned herein is strictly limited to this transaction alone.

4. DELIVERY:

a. The Service Provider shall configure the RLMS software and is responsible for carrying out design, installation and implementation of the RLMS software at the premises of the Institution at Vijayawada including providing first year annual maintenance support services during the agreement period.

The Service Provider shall design and deliver the RLMS software addressing the scope mentioned in section two and provide the 2 year AMC support activities.

c. The Service Provider should complete module(s), systems and implementation tests as are necessary to verify that the software solution is in accordance with the agreed requirements of the Institution and is ready to be installed.

5. Deliverables and Sign Off

- End User Training of the application Service Provider needs to provide the training on the entire application (i.e. web and mobile app) to the department authorized personnel in two separate tranches. i.e. one session during the implementation and second session as part of refreshing training session after completion of six months after implementation.

Institution shall given a sign off to the Service provider for each of the above mentioned deliverables.

Both the parties agree that this agreement is not intended to create a relation of partnership, joint venture or an association between the Institution and the Service Provider of any kind whatsoever.
